I hereby Certify the above to be a correct Plat of L. A. Culver and A. J. Vorhes and Frank Gallagher's Addition to the Village of Logan, Hocking County, Ohio: Being a part of Fractional Lot No. 15 Section No. 11, Township No. 14, Range No. 17, Hocking County, Ohio. Beginning on the South line of said Lot and West side of Gallagher Avenue from which the South West corner of Lot No. 739 in Friesner and Gallagher's Addition to Logan bears N 39 3/4 E 21 links and N 48 E 75 links, thence West 5.66 chs, thence N 42 W 3.45 chs, thence S 48 W 2.26 chs to the North line of the Lot owned by the Motherwell Iron and Steel Co., thence by the North line of said Lot N 79 W 4.87 chs to the East Bank of the Hocking River; thence by the East Bank of said River N 26 1/2 W 3.33 chs, thence N 34 1/4 W 1.85 chs, thence N 47 1/4 W 2.26 chs to the West line of said Lot, thence N 20 E 8.61 chs to the South side of the Towing Path of the Hocking Canal, thence by the South side of said towing path S 71 E 8.15 chs, thence S 78 E 1.16 chs, thence S 84 3/4 E 3.56 chs, thence N 68 1/2 E 4.00 chs, thence East 1.65 chs, thence S 69 E 5.87 chs to the North West corner of Kessler's lot, thence S 48 W 2.09 chs to the East line of Lot No. 726 in Friesner and Gallagher's Addition to Logan, thence N 42 W 9.7 chs, thence S 48 W 9.6 1/2 chs, thence N 42 W 3.00 chs to the North West corner of said Friesner and Gallagher's Addition, thence by the West line of Friesner and Gallagher's Addition S 48 W 11.78 1/2 chs, thence S 42 E 5.07 chs, thence S 39 3/4 W 2.21 chs to beginning, containing 17.85 acres. - Also a part of Fractional Lot No. 13, Section No. 14 same Township and Range; Beginning at a point on the North line of said Lot from which the South West corner of Lot 739 in Friesner and Gallagher's Addition to Logan bears N 39 3/4 E 21 links and North 48 E 75 links, thence by the West line of Gallagher Avenue S 39 3/4 W 8.85 chs to the North line of the lands owned by the Columbus Hocking Valley and Toledo Rail Road Co., thence N 79 W 9.98 chs, thence N 42 W 3.26 chs to the North line of said Lot thence East 5.66 chs to beginning, containing 9 1/100 acres, the two tracts hereby described estimated to contain 18.76 acres.
