

Record of Murray City, see Plat on preceding page.

The town of Murray City is located in Hocking County Ohio, in the East half of the Northeast quarter of section 3 township 13 Range 15, of the Ohio Company's purchase, and part of the South East quarter of section 4, township and range aforesaid. This survey commences at a stone at the south end, west side of the street designated on the plat as Lafollett Street, said stone is in a line run parallel to the quarter section line of S.E. quarter of Section 3, South side, and 33 ft north of said or section line. — From said stone Lafollett Street runs North 31° E to a stone at the intersection of said street with Cyprus Avenue, said Street is 40 feet wide. The next street westward in the plat Atherton Street is parallel to Lafollett Street and is 33 feet wide and terminates in Cyprus Avenue. — All other streets westward of Atherton street are 40 feet wide parallel to Lafollett Street and terminate in Cyprus Avenue at its junction with Railroad Avenue. — Cyprus Avenue starts at the second stone mentioned above, (which is N 31° E 1354 ft from the first) and runs N 59° West 1241 feet. it is 66 feet wide. From same stone Railroad Avenue runs N 16° W 2284 ft including the width of Cyprus Avenue, said Avenue is 116 feet wide at southern end 68 feet at junction with Cyprus Avenue from thence to its Northern terminus it is 100 feet wide. — To the westward of Railroad Avenue and southward of Cyprus Avenue streets and alleys run parallel to R.R. Avenue and cross streets and alleys run at right angles thereto. Alleys parallel to R.R. Av. are 16 ft. wide, cross alleys 12 ft. Cross streets 40 feet from Cyprus Av. northward, and on both sides of R.R. Av. streets and alleys run parallel thereto. Streets 40 feet wide and cross streets and alleys run at right angles viz N 74° West Streets 40 ft Alleys 12 ft. All full lots are 50 ft front and 100 ft back and contain 1/2 of an acre of land. The dimensions of fractional lots are entered on the plat. There is no lot numbered 433, that number being omitted by accident 515 was also omitted in like manner and there are no lots of that number. The south line of the town running parallel to the quarter section line of N.E. q. Sec 3 T. 13 R. 15 has a total length of 2100 feet. The streets and alleys as above described and as shown by the accompanying plat and as surveyed by me are dedicated by the Snow Fork Coal and Mining Company as such streets and alleys to the public use. I hereby certify the accompanying plat to be a correct plat of said town as surveyed and platted by me.
