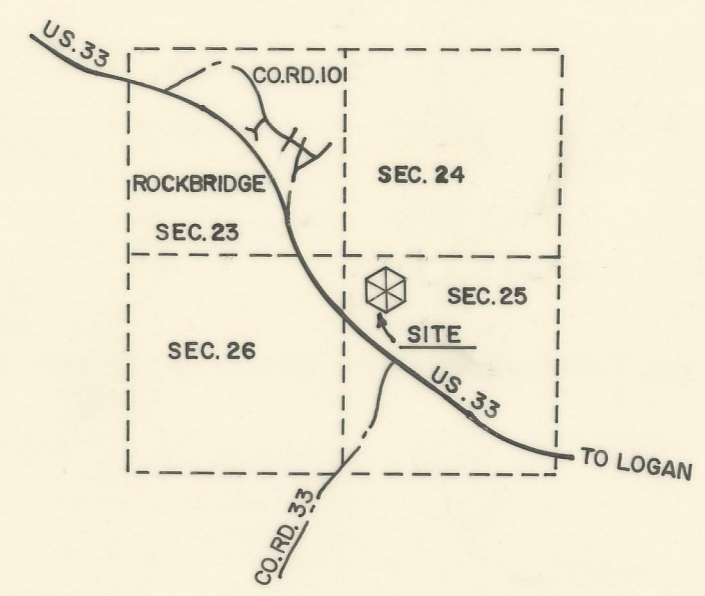


# 1 ST. ADDITION - PAUL STUART SUBDIVISION
