

Being a part of sections numbers 13, 14 & 17. Full Township Hoeking County, Ohio and particularly described as follows to wit Beginning at a point (A) in the former South Corporation line of the Village of Logan, Ohio, where the former is intersected by the line running North and South that was the division line between the lands formerly owned by Joseph R. Roberts and William Gallagher in said section No 14; thence with said division line south 750 feet to the South West Corner of the Logan water works lot; thence with the south line of said water works lot S. 75° 41' E. 404.5 feet; thence S. 50° 41' E. 40 feet to a point in said south line; thence south 75 feet to the N.W. Corner of lot No 1431, as shown on the plat; thence S. 15° 38' W. 165.5 feet; thence S. 42° 44' E. 52.2 feet; thence S. 3° 52' W. 222 feet; thence S. 24° 57' W. 51 feet; thence S. 19° 03' W. 200 feet to a point South East of the East line of lot No 1438 as indicated on the plat, and 11 feet distance from the S.E. Corner thereof in a South East direction on the arc of a circle the radius of which is 1061 feet, and the center of which is on a distance 1516.5 feet; thence S. 76° 52' E. 194 feet to a point being the S.E. Corner of lot No 1518 of the plat; thence S. 4° 45' W. 18 feet; thence S. 85° 10' E. and crossing the line between sections 14 and 13 at 60 feet, a total distance of 630 feet to the East line of lot No 41, thence with said East line and the same continued North 2500 feet to "B" in the former South Corporation line of said Village thence westerly with said line to the place of beginning.

The Streets and Alleys in this addition were heretofore dedicated for public use by a plat recorded in plat Book B, plats of Allotments Hoeking County pages 36 & 37 measure as shown on the plat in feet, and the scale is 100 feet = 1 in
