

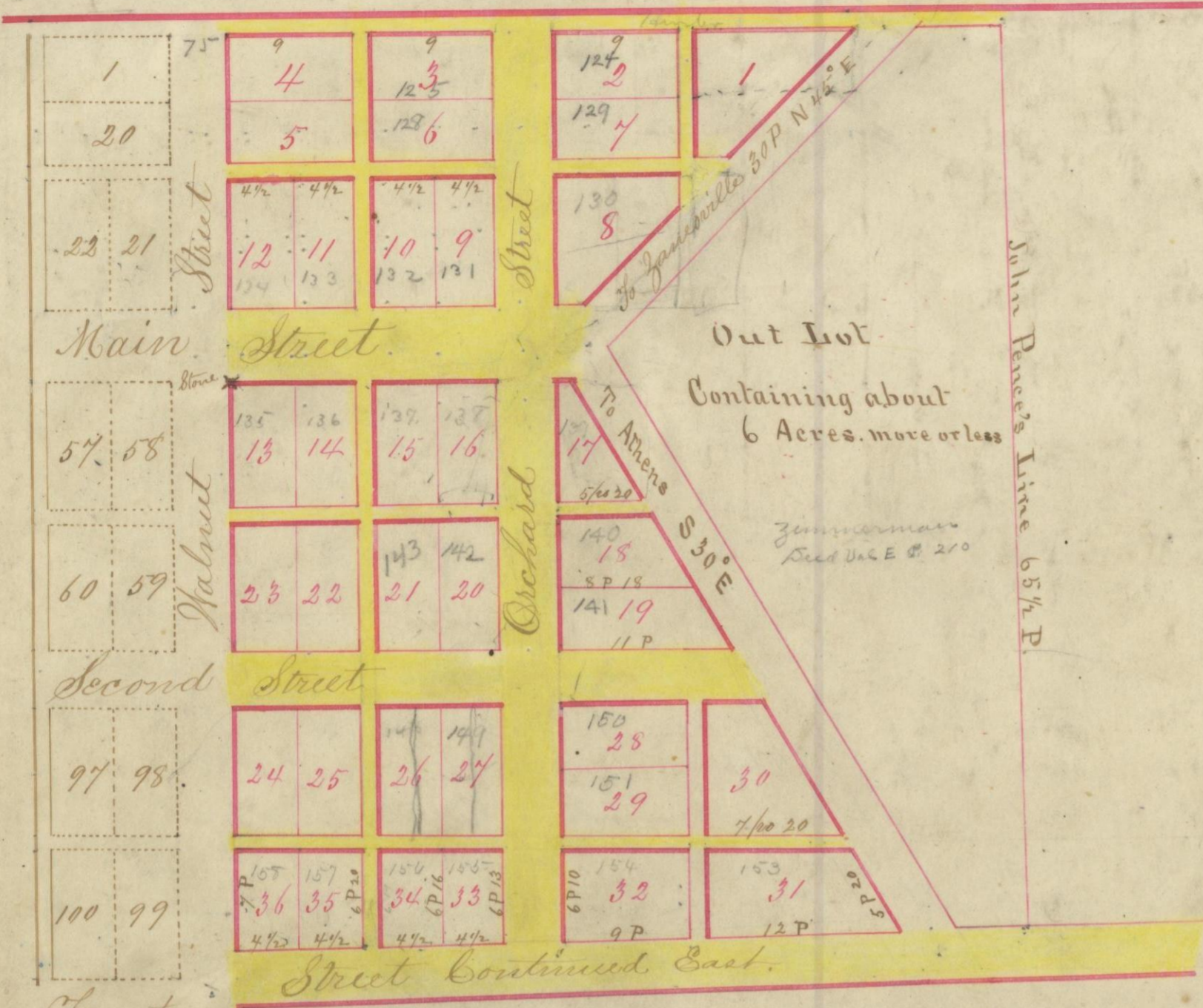
Culver and Hunsicker's addition to the Town of Logan.

Plat of additional In Lots and Out Lots to the town of Logan on the East side of said Town, laid out June 30, 1836, by R. Culver and Samuel Hunsicker.

Plat drawn on a scale of ten poles to an inch, at the Northwest corner of Lot No. 13, at the intersection of Main and Walnut Streets a stone is planted for a commencement. Lots Nos. 13, 14, 15, 16, 20, 21, 22, 23, 24, 25, 26, 27, 28, and 29 are each $4\frac{1}{2}$ poles wide and 9 poles long. Nos. 17, 18, 19, 30, 31, 32, 33, 34, 35 and 36 are of unequal sizes and irregular figures. Orchard Street continued is the Athens State Road. The lots numbered 1, to 12, inclusive on the north of Main Street are laid out by Samuel Hunsicker.

I, Henry Westenhaver, surveyor of Hocking County, hereby certify the above Plat and explanations to be correct. Henry Westenhaver
I do hereby certify that I have laid off the foregoing addition to the Town of Logan, with the exception of Lots Nos. 1 to 12 inclusive, and I do hereby convey to the Town all the Streets and Alleys in said Plat from and after the first day of January next excepting the streets and alleys east of Orchard Street, which street and alleys I reserve the powers of opening or not, as I may hereafter deem expedient. Witness my hand and seal this 2nd July 1836. R. Culver.
