

Brook & Bragg's Addition Continued.

The streets and alleys are as follows, those running in the northern and southern directions are all laid down due north and south, with a variation of 2° 15' to the east or right of the magnetic bearing.

A space commencing at the south west corner of Lot No 25, with a width of 14 1/2 links, and extending to and terminating at the north west corner of Lot No 8, with a width of 35 1/2 links is appropriated for the use or purpose of a street or alley and is to be denominated Western Space. A space 24 1/4 links wide, commencing at the southern ends of Lots Nos 26 & 27, and extending to the northern ends of Lots Nos 6 & 7 is appropriated for the use and purpose of an alley and is to be denominated Depot alley. A space of 100 links wide commencing opposite the south western corner of Lot No 37 and extending to the northern ends of Lots Nos 4 & 5, is appropriated for the use and purpose of a street, and is to be denominated Depot street.

A space 24 1/4 links wide commencing at the southern ends of Lots Nos 38 & 39 and extending to the northern ends of Lots Nos 2 & 3 is appropriated for the use and purpose of an alley and to be denominated Eastern alley.

The Streets and Alleys, running in an eastern and western direction are all laid down due east and west, with a variation of 2° 15' to the East or right of the magnetic bearing, excepting the space in the southern side of the addition, which is laid parallel to the south boundary line of the section aforesaid and has a variation of 0° 50' to the east or right of the magnetic bearing, this latter space being 45 1/2 links wide, commencing on the eastern side of said addition opposite to the south east corner of Lot No 40, and extending west to the Eastern side of Bowers lot, is appropriated for the use and purpose of a street and to be denominated Front Street. A space 24 1/4 links wide commencing on the Eastern side of Lots 33 & 40 and extending to the western sides of lots 36 & 37 is appropriated for the use and purpose of an alley, and is to be denominated South Alley. A space of 100 links wide commencing on the eastern sides of Lots Nos 32 & 33 and extending to the Eastern side of Bowers Lot, and being there diminished to the width of 25 1/2 links, and thence extending to and terminating at the western side of said addition near the south west corner of Lot No 25 with a width of 35 1/2 links is appropriated for the use and purpose of a street and is to be denominated second street. A space 24 1/4 links wide extending from the eastern sides of Lots Nos 17 & 32 and extending to the western sides of Lots Nos 24 & 25 is appropriated for the use of an alley and is to be denominated Middle Alley. A space 125 links wide commencing on the eastern sides of lots Nos 16 & 17 and extending to the western sides of Lots Nos 9 & 24, is appropriated for the use and purpose of a street and is to be denominated main street. A space 24 1/4 links wide commencing on the eastern sides of Lots Nos 1 & 16 and extending to the western sides of Lots Nos 8 & 9 is appropriated for the use and purpose of an alley and is to be denominated North alley. And space 88 1/2 links wide commencing in the north east corner of said addition opposite the north east corner of Lot No 1 and extending westwardly to the north western corner of said addition, near the North west corner of Lot No 8 is appropriated for the use and purpose of a street and is to be denominated Hunter Street - All the foregoing Streets and alleys running in the eastern and western direction as aforesaid, excepting South alley and Hunt Street, viz: Hunter Street, North Alley, Main Street, Middle Alley, and Second Street, are so located that the corresponding streets and alleys in the said town of Logan being produced and continued eastwardly will make said streets and alleys in the addition an exact prolongation of said streets and alleys in the original plat of said town of Logan.

The width and depth of the lots, together with the width of the streets and alleys, are marked on the plat in links and fractional parts of links. The addition made up of Lots, Streets and Alleys as above enumerated and described is to be known and designated by the name and title of Brook and Bragg's addition to the town of Logan. Stones are planted at the following places, to wit: a Free Stone estimated to weigh 40 lbs, in the center of Depot Street and the South side of Hunter Street. A free stone estimated to weigh 30 lbs in the center of Depot Street and the North side of Second Street, A Free stone estimated to weigh 45 lbs in the center of Main Street at its termination at the eastern side of the addition. A Free Stone estimated to weigh 45 lbs at the south east corner of Lot No 40. A Free Stone estimated to weigh 30 lbs at the South east corner of Bowers Lot, the same being 45 1/2 links South of the north side of Front Street, and 29 1/4 links west of the west side of Depot Street. A Free stone estimated to weigh 35 lbs at the North East corner of Bowers lot, the same being 38 links west of the west side of Depot Street and 25 1/2 links south of the North side of Second Street. A Free Stone estimated to weigh 35 lbs at the North west corner of said Bowers Lot, the same being 38 1/2 south and 14 1/2 links west of the South west corner of Lot No 25. A free stone estimated to weigh 45 lbs on the west boundary line of said Addition 23 1/2 links west of the North west corner of Lot No 24. A free stone estimated to weigh 30 lbs in the west boundary line of said Addition 35 1/2 links west of the North west corner of Lot No 8.
