

An Ordinance

Providing for the annexation of certain territory to the Village of Logan.

Sec. I. - - Be it ordained by the Council of the village of Logan, That the annexation of the following described territory, lying contiguous to the Village of Logan, aforesaid, is hereby authorized, viz: so much of the county of Hocking and State of Ohio, as is contained in the following lines. Beginning at a post at the south east corner of the present corporate limits, in the south edge of the towing path of the Hocking Canal 200 links south of the north east corner of the east half of section number 13, township number 14 range No. 17 thence by the south edge of the towing path south easterly about 40 chains to the west line of said section No. 13 at the south end of the Canal bridge, thence continuing westwardly by the south edge of the towing path through sections Nos. 14 and 11, same township and range about 63 chains to a stone on the east line of G. W. Alfreds land, thence South 20° W. 8.61 chains to the north bank of the Hocking River, thence N. 54° West 5.65 chains to a stone at the South west corner of Thomas Northingtons addition to the Village of Logan thence N 14° E 27.03 chains to a stone at the North west corner of Old Corporation limits thence West 20.32 chains to the west line of section 11 Township 14 Range 17, thence South by said line 21.53 chains to the center of the Hocking River thence by said River southeasterly to its intersection with the fence continuing on the south side of the Columbus and Hocking Valley Railroad, thence by said fence south easterly about 96 chains to the east line of the east half of section 13 Township 14 Range 17, thence North 20.33 chains to the place of beginning.

Sec. II. That S. H. Bright, Village solicitor be and is hereby empowered and directed to prosecute such proceedings before the Board of County Commissioners and elsewhere, as may be necessary to effect the legal annexation of said territory to the Village of Logan.

Petition. To the Hon. Commissioners of Hocking County Ohio.

Your petitioners the Corporate Authorities of the Incorporate Village of Logan, in your said County of Hocking would most respectfully represent to your Honorable Board that under an ordinance duly and legally passed for that purpose by the Council of said Village the territory therein described was authorized to be annexed to said Corporation it being contiguous thereto, a plat of which territory is hereto attached and marked "A" and which territory is described as follows, viz: being so much of the county of Hocking and state of Ohio as is contained in the following lines. Beginning at a post at the south east corner of the present corporation limits in the south edge of the towing path of the Hocking Canal 200 links South of the N.E. corner of the east half of section 13 township 14 range 17, thence by the south edge of the towing path south westerly about 40 chains, to the west line of said section No. 13, at the south end of the canal bridge, thence continuing westerly by the south edge of the towing path through sections Nos. 14 and 11 same town. and range about 63 chains to a stone on the east line of G. W. Alfreds land. Thence south 20° W 8.61 chs to the North bank of the Hocking River, thence north 54° W 5.65 chains to a stone at the South west corner of Thomas Northingtons addition to the Village of Logan, thence N 14° East 27.03 to a stone N West corner of present corporation limits thence west 20.32 chains to the west line of Section 11 Town 14 Range 17 thence by said line south 21.53 chains to the center of Hocking River, thence by said River southeasterly to its intersection with the fence continued on the south side of the C. & H. V. R. R. thence by said fence south easterly about 96 chains to the west line of the east half of section No. 13 T. 14 R. 17, thence north 20.33 chs to the place of beginning containing one hundred and seventy eight and $\frac{500}{1000}$ acres. Your petitioners further represent, that by the terms of said ordinance S. H. Bright Village solicitor is duly authorized, and directed to prosecute such proceedings before you as may be necessary to effect the legal annexation of said territory to said Village. Your petitioners therefore pray that a time be fixed for the hearing of this petition and that such proceedings be had by your Honorable Board as may be required by law to complete the annexation of said Territory to the said Village of Logan.
