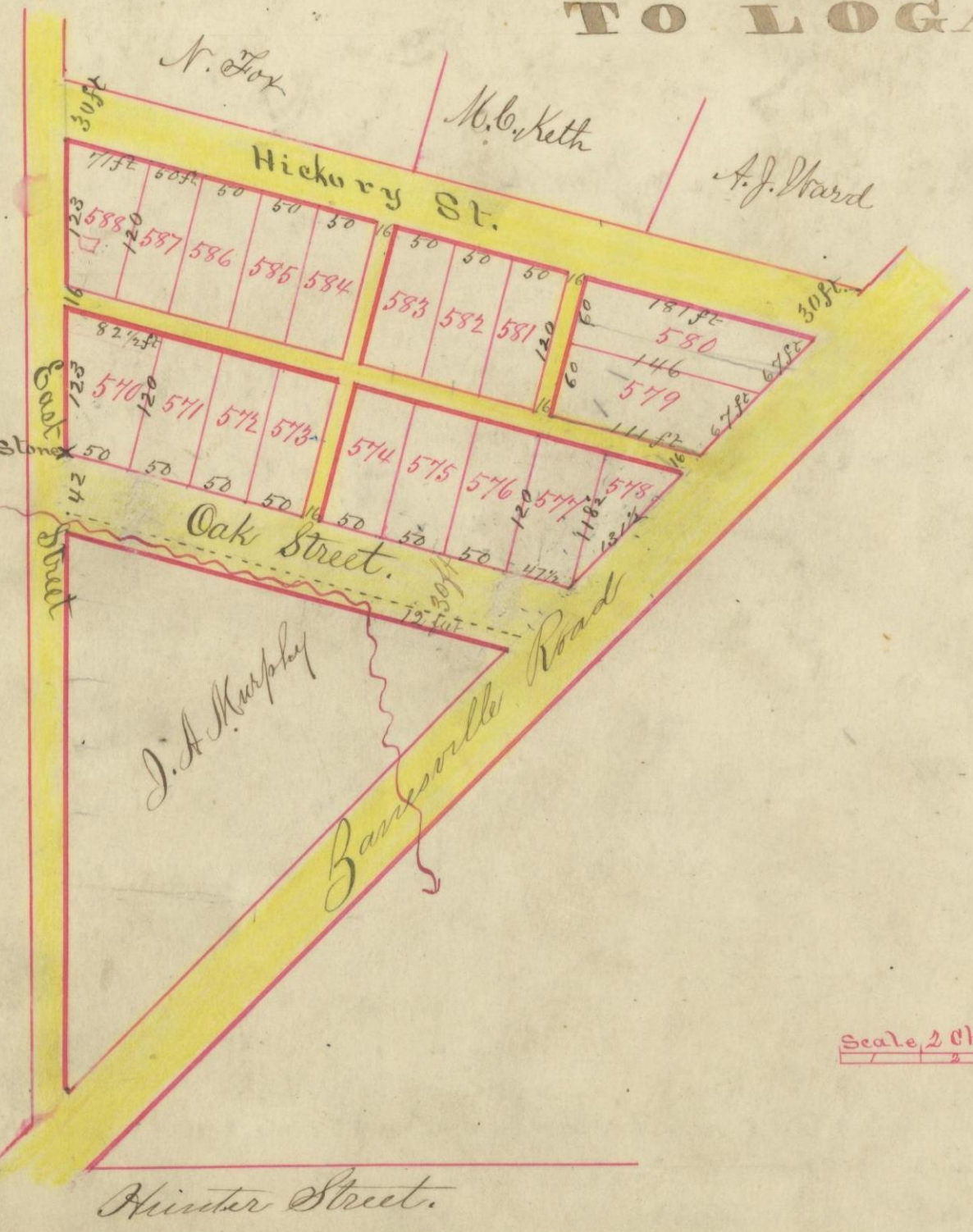

I hereby certify the foregoing to be a correct copy of William Stallsmith's addition to the Village of Logan, Hocking County, Ohio. Beginning at a point 7.11 chains north of the southern extremity of Fractional Lot 12, which extremity is at the intersection of the northern boundary of the Bangorville Road with the eastern boundary of East Street, in the village of Logan. Thence south 68° East 5.76 chains to the northwestern boundary of the Bangorville Road, thence in a N.E. direction along said road and said Fractional Lot 12, 6.21 chains to the North east corner of said Lot, thence in a North west direction along the northern boundary of said Fractional Lot 12, 10.32 chains to a point on the eastern boundary of East Street 4.97 chains North of beginning, thence to beginning containing 4.10 acres. Said tract embracing 19 lots numbered from 570 to 588 inclusive. The dimensions of all lots, and width of all streets and alleys are given in feet respectively. Given under my hand this 27 day of November 1880

Be it known that I William Stallsmith of the county of Hocking and State of Ohio proprietor of the said addition to the Village of Logan, do set apart and dedicate, to public use all the streets and Alleys designated by the foregoing plat and caused a stone to be planted at the south west corner of Lot No 570.
