Allen being sworn says that he set up a notice of which the above is a true copy in two public places in ward township on the 25<sup>th</sup> day of January 1878 Chas. Butler sworn to and subscribed before me this 21<sup>st</sup> day of February 1878 M. D. Hickman Notary Public (Seal) Thereupon at the February Term 1878 of said court the following journal entry and decree of the court was made to wit: In the matter of the Petition of Dorn Finley P. O. Crighton Lydia Fuller & others to vacate certain portions of the Town Plat of Leabon Hill of said County of Hocking. This day the cause came on to be heard upon the petition of Dorn Finley & others filed January 15 1878 and there upon it is made to appear to the court by the testimony of witnesses that there are no persons owning any lot or lots in said town plat described in the petition not assenting to the vacation of said plat. That due notice of the pendency & prayer of said petition has been given according to law and that the statements of said petition are true. It is further made to appear to the court that it will conduce to the general interest of said town to vacate the streets & alleys named in and that portion of the plat of said town set out in the petition as prayed for in said petition. It is therefore ordered by the court hereto that so much of the town plat of said Leabon Hill as is embraced in. In lots nos one hundred and forty seven together with so much of second street as lies between said Lots nos 141 & 142 and so much of third street as lies east of and adjoining said Lot No 147 and the whole of the alley between said Lots nos 144 & 145 and the whole of Crighton and Fallers addition to said town as made January 17, 1874 and as the same is designated on the plat recorded thereof be and the same is hereby vacated. It is further ordered that said petitioners pay the cost of this proceeding and that execution issue against them thereof.
