This is to certify I laid out for Lewis Green and S. H. Wright, certain lot as indicated by the above plat, said lots being fractional parts or lots of fractional lot No 21, of Section 13, Township 14, Range 17, Hocking County, Ohio, reference being had to Book A, Records of Fractional Lots, Hocking County Ohio, beginning at a point 40 ft east of the North west corner of said fractional lot No 21, thence South 20 ft to the NW cor of lot No 51, of said fractional lot No 21, of said section at which point a stone of suitable size is planted, thence S 39 1/2 ft to a stone at the North west corner of lot No 52, thence S 26 1/2 ° E 41 1/2 ft to a stone at the N.W. corner of lot No 3, thence in the same direction 168 to the South line of said fractional lot No 21. The bearing of all lines, save such as correspond with the Cardinal points of the Compass are marked on the Plat, all distances are marked on the Plat in figures indicating feet as is also the quantity of Land each lot contains, and numbers of lots from No 1 to 58 inclusive. Orange, Mulberry, Poplar Plum and Oak Streets are each forty feet wide throughout their length and have directions as indicated on the plat. Maple, Chestnut and Elm Streets are each fifty feet wide throughout and have directions as indicated on the plat. Cherry St, is forty feet wide at its western extremity and continues the same width to its intersection with Maple St, and from thence to its terminus it is fifty feet wide. Vine Street is 25 feet wide at its west end containing said width till intersected by Spring Avenue, from thence to its eastern terminus it is 40 ft wide. Orchard, Sycamore and Walnut Avenues are each 20 ft wide and Prospect Avenue is 25 ft wide. Spring Avenue is of irregular width its eastern boundary being such as to include in its limits the small watercourse as indicated on the Plat. The Alleys are all 16 ft wide. Silas H. Wright (S.D.). Signed, sealed and acknowledged, as the voluntary act and deed, of the said Lewis Green and S. H. Wright the proprietors of said Territory, witness my hand and seal this 10 day of July A.D. 1882.
