

Descriptions of Lands Dedicated, to Use of Village of Logan for Street.

Description of Ponds Tract.

Being part of fractional lots Nos. 4 & 5 attached territory to the Village of Logan and in Section 11 Twp. 14 R 17 Hocking County, Ohio, beginning at the S.E. corner of lot No. 226 in said Village, thence along the N. line of Hunter St. S 89 1/2 E. 44 feet, thence N 1/2 E. 172 1/2 ft. to a point in a line with N. side of the 8 1/4 ft. alley as laid out along the E. end of lot No. 186 of said Village, thence S. 89 1/2 E to and along the N. side of said 8 1/4 Alley, to a point in a line with the east side of said lot No. 186, thence N 1/2 E 8 1/4 ft. to a post, thence N 89 1/2 W 105 ft to a post, thence by a curve to the left, on a chord bearing N. 24 1/2 W with a Rad. of 197.7 ft, 83 ft. on ch. to a post, thence on a ch. bearing N 53 W, curving to the right, with a radius of 219 ft, 80 ft. on ch. to a post, thence N. 34 W 33 ft. to a post, thence N 1/2 E. 57 ft. to a post in the S. boundary of a St. or Road running N. through said fractional lot 4, thence N 89 1/2 W 44 ft. thence S 1/2 W 66.5 ft. to a post, thence S 34 E. 56.75 ft to a post, thence S 53 E 114.84 ft. to a post, thence S 89 1/2 E. 19.8 ft to N.E. cor. of Lot No. 225 Logan Village, thence by the east line of said lots Nos. 225 & 226, 214.5 ft. to beginning, Containing .43 of an acre, more or less.

Description of H. C. Smith's.

Being part of Lu. Lot No. 225 in the Village of Logan, beginning at S.E. Cor. of said lot, thence by a curve to the left on a ch 76 ft. in length bearing N 24 1/2 W Rad. 153.7 to the N. line of said lot, thence South 89 1/2 E. 28.6 ft. to the N.E. cor. of said Lot, thence S 1/2 W 66 ft. to beginning, Containing .02 acres, more or less.

Description of J. W. Jones.

Being part of fractional Lot No. 4, Sec. 11, T 14, R 17, attached territory to the Village of Logan, beginning at a point on the N. line of Lu. Lot No. 225 said Village and distant 19.8 ft. from the N.E. cor. thereof, thence N. 53 W 114.84 ft. to a post, then using 97 ft. of the E. end of said line as a ch. with a curve to the left, with a Rad. 263 ft, and 1/2 of ch. equal to 50 ft. and by a curve to the right, from the S end. of said arc to the S line of said fractional lot with a Rad. 153.7 ft. and intersecting said south line, at a point, 8.8 ft. from beginning, thence by said S. line S 89 1/2 E 8.8 to beginning, Containing .01 acre, more or less.
