Together with the petition for its annexation and other papers relating thereto, and a certified transcript of the proceedings of the county Commissioners in relation thereto are on file with the clerk of the council of said Village and the same is hereby accepted.

Sec. II-This ordinance shall take effect and be in force from and after the earliest period allowed by Law. Done at the Council Chamber in Murray City, Ohio, this 8th day of December 1903.

The following are the proceedings had on the above ordinance: by the Village Council of Murray City, Ohio: Said Council was called to order by the Mayor, Wm H. Hudson, on the 8th day of December 1903, pursuant to a call by the said Mayor. The roll being called by the Clerk, the following responded: Swank, Roberts, Shivers, George, Thomas and Brooker.

The President hereupon advised council of the purpose of the meeting under the call. Thereupon K. C. Swank moved that the above said ordinance be placed upon its first reading, Regularly seconded by J. R. Roberts. The question being called for the vote was taken and result- etc. in Yeas 4, Nays 2. The motion was declared carried. The ordinance being read, K. C. Swank

moved its passage, said motion being seconded by A. Thomas. The question being called for, the Clerk was instructed to call the roll: Brooker, George, Roberts, Swank and Thomas voted Yeas; Shivers Nay. Motion declared carried and that ordinance had, carried on its first reading.

On motion of A. Thomas, duly seconded by L. George the suspension of the regular rules for passing ordinances was placed for passage and the question being called for the vote was taken, resulting Yeas, 5, Nays, 1. Motion declared carried. The Clerk was therefore ordered under the motion to read ordinance and by motion of J. R. Roberts, duly seconded by A. Thomas it was placed upon its second reading, Thereupon Clerk read same; The question being called for, the vote was taken: Yeas- Brooker, George, Thomas, Roberts, Swank; Nays, Shivers, Same declared passed as to its second reading.

L. George moved that the rules regular for passing ordinances be suspended which was duly seconded by A. Thomas. The question being called for, the same was placed for vote resulting, Yeas, 5; Nays, 1. It was thereupon moved by J. R. Roberts that the ordinance be placed upon its third and final reading. Clerk reading same, duly seconded by K. C. Swank, The question being called for the

same was placed for final vote and the Clerk ordered to call the roll, result, Brooker, Roberts, Swank, George and Thomas voting Yeas; Shivers, Nay. The President thereupon declared that ordinance had passed according to the votes duly taking according to Law.
