The Matter of the Annexation of Contiguous Territory.

Petition.
Annexation of Contiguous Territory to the Village of Logan, Ohio.
To the Hon. The Board of Commissioners of Stocking County, Ohio:
Your petitioners hereby pray your honorable body to grant the annexation
of the following contiguous territory to the corporate limits of the Village of Logan,
in said County, which territory is described as follows, to-wit: Being a part
of Fractional Lots Nos. 9 & 18 of Section 11, Township 14, Range 17 said Stocking
County and bounded as follows, beginning at the point marked "A." on the
accompanying plat thence South 3.28 chains to the Corporation line; thence
West 4.26 1/2 chains to West line of Lot 18; thence North 3.17 chains; thence East
4.26 1/2 chains to the beginning containing 1.40 Acres; Second: beginning at
the North East Cor. of Lot 21 1/4 of said Village; thence West 7.64 chains to the
North West cor. of Trac. Lot 18; thence South 3.17 chains to the present
Corporation line; thence West 5.36 1/2 chains to a post; thence North 4.18
chains to the South West corner of Oak Grove cemetery; thence East along
the South line of said cemetery 13.00 1/2 chains to the West line of
Market Street; thence South 1 chain to the beginning three Acres.
Total of both tracts being 4.4 Acres, all of which more fully appears in the
accompanying plat marked "Exhibit A."

Your petitioners further represent that there are no residents on
said territory and that John E. Rauch and Maynard Pond are the sole
owners thereof. That said territory should be annexed to Logan for the
proper and convenient care of the streets and alleys on and contiguous
thereto.

We your petitioners therefore pray that said territory may be annexed
as above set forth and hereby designate and appoint George Spill and
Frank Brown our Agents to act in securing said annexation.
