

and transact, accomplish & finish all matters and things whatever, relating to the premises, in as ample a manner as our constituents might or could do were they personally present, by virtue of the authority vested in us, as well by special powers of attorney as by the articles of association originally entered into by the aforesaid proprietors. Do by these presents award, pronounce, publish and declare that the foregoing list of names and numbers describes the division and partition of the lands of the Ohio Company, divided, allotted and sett off as aforesaid to each proprietor or associate, composing the Ohio Company, agreeably to their several rights and interests, to be held by them, their heirs and assigns in severally forever. Provided however, that nothing is hereby intended to prejudge the claim of any person or persons not herein named, to any share or shares to which he or they may have a right.

Therefore we whose names and seals are affixed as aforesaid, in behalf of ourselves and the proprietors in the aforesaid company whom we represent and those who of right ought to be concluded hereby, Do relinquish and forever quit-claim to each proprietor as aforesaid, his heirs and assigns forever the several lots of land being part of the Ohio Company's purchase, which have been allotted and divided to him as aforesaid, and which are described by the numbers annexed to his name as aforesaid.

To have and to hold in severally as aforesaid, to each proprietor as aforesaid, his several lots as aforesaid, with the appurtenances thereto belonging. To each proprietor his heirs and assigns forever. And to perpetuate this our deed and render it less liable to be altered, or any part thereof destroyed or lost. Rufus Putnam, Benjamin Tallmadge and John Mawney, Esquires have set their names on each leaf thereof, beginning at page one hundred & eighty one and ending at page two hundred and twenty two.
