To the Village of Logan, Ohio

An Ordinance to Authorize Annexation of Certain Territory to the Village of Logan, State of Ohio.

Be it Ordained by the Council of the Village of Logan, State of Ohio,

Sec. 1.- That the annexation of the following described territory; situate in Section 11, Falls Township, Hocking

County, Ohio, and bounded as follows; beginning at a stone in the South East corner of a tract of land of

26.2 Acres, known as the Mary Dye Land in said Section 11, Falls Township, Hocking County, Ohio; thence

North 87° West 337 feet; thence North 456.27 feet; thence North 84° West 20.49 chains; thence South 6° West

14.90 chains; thence South 77 $\frac{1}{2}$ ° East 16.80 chains to the place of beginning." be and the same is hereby authorized.

Sec. 2.- That John L. Pettit, Attorney for said Village be and he is hereby authorized to prosecute the proceedings necessary to effect such annexation.

Sec. 3.- This Ordinance shall take effect and be in force from and after the earliest period allowed by law.
