Anexation of territory to Murray City, O.  
Certified Copy of Proceedings.

Council Chamber Murray City, Ohio, June 17<sup>th</sup> A.D. 1892.

The Council of the Village of Murray City, O., met this day in regular session; Mayor W<sup>m</sup> Snowdon in the chair, roll and the following members present; Anderson, Masters, Nabauer, Hanie and Fircu. Minutes of previous meeting read and approved.

In the Matter of the Extension of the Incorporate limits

Motion by Anderson, that the first and second reading of the ordinance pertaining to the annexation be dispensed with, and the said ordinance duly passed. By vote, Yeas 5, Nays 0.

An Ordinance

To all whom it may concern<sup>s</sup> - Be it ordained by the Council of the village of Murray City, O., that the corporate limits of Murray City, O., be extended to take in all of Adams Addition, as shown by a plat on file in the Mayor's office of said village. Said territory is described as follows, to wit: Being part of Fractional lot No 1, Section No 4; and Fractional lots No. 6, 7, 8 and 9 of section No 3, Township No 13, Range No 15. Ohio Company's Purchase, Hocking County, Ohio. Beginning at the Northwest corner of present corporation, thence west 1332.5 feet, thence South 370 feet; thence East 1055 feet; thence South 3189 feet; thence East 821.4 feet to southwest corner of said corporation, thence with corporation line to beginning containing 89.92 acres more or less.

That William Snowdon, Village Mayor is duly authorized and directed to have prosecuted such proceedings before the Commissioners of Hocking County, necessary to effect the legal annexation of said territory to said village.

To the Honorable Board of Commissioners of Hocking County, Ohio: Your petitioners, the corporate authorities of the incorporated village of Murray City in your said county and state, respectfully represent to your Honorable Board: that by virtue of an ordinance duly and legally passed for that purpose, by the council of said village, on the 17<sup>th</sup> day of June, A.D. 1892, and duly published on the 10<sup>th</sup> day of July, 1892, and that the territory is contiguous thereto, a plat of which territory is hereto attached, marked "Addition to Corporation"; said territory is described as follows to wit: Being parts of Fractional lot No 1, Section No 4, and Fractional lots No 6, 7, 8 and 9 of section No 3 Township No 13, Range No 15. Ohio Company's Purchase, Hocking County, Ohio; - Beginning at the Northwest corner of the present corporation, thence west 1332.5 ft; thence South 370 feet; thence east 1055 feet; thence South 3189 feet; thence East 821.4 feet to Southwest corner of said corporation; thence with the corporation line to beginning: Containing 89.92 acres, more or less. Your petitioners further represent that by the terms of said ordinance, William Snowdon, Mayor, is duly authorized and directed to have prosecuted such proceedings before you as may be necessary to effect the legal annexation of said territory to said village. Your petitioners therefore pray that a time be fixed for the hearing of this petition, and that such proceedings be had by your Honorable Board as may be required by law to complete the annexation of said territory to the said village of Murray City, Ohio.
