And further represent that for the better regulation, government and improvement of said Village, it is necessary that it be incorporated, that the territory included in the following tract and not laid out in town lots is adjacent to said lots and should be included within the limits of the incorporate bounds of said Village, and prayng that said Board of Commissioners grant an order of incorporation of the following territory (a correct map of which is filed with said petition and marked exhibit "A") situate in the Township of Ward, County of Hocking and State of Ohio, and bounded as follows, to-wit: Being a part of Fractional Lot No. 1, Section No. 4, Township No. 13, Range No. 15, Ohio Company's Purchase, Hocking County, Ohio, and a part of Fractional Lots Nos. 6, 7, 8 and 9, Section No. 3, same Township and Range, beginning at the north-east corner of said Lot No. 1, Section No. 4, and North-east corner of Watkins addition to the Village of Murray City, thence west 8.00 chains to the north-west corner of said addition, thence east 17.81 chs., thence S. 41 $\frac{1}{2}$  E. 6.00 chs., thence S. 55 $\frac{3}{4}$  E. 1.14 chs., thence S. 28 $\frac{1}{4}$  E. 8.41 chs., thence S. 39. E. 7.66 chs., thence S. 13 $\frac{1}{2}$  E. 8.67 chs., thence S. 9. W. 11.97 chs., thence S. 29.
