

Please before the Honorable J.S. Trisner one of the Judges of the Seventh Judicial District of Ohio began and held at the Court House in the Town of Logan County of Ohio, on the 21<sup>st</sup> day of May 1882.

Be it remembered, that heretofore to-wit: April 11<sup>th</sup> 1882, the following petition was filed in the Court of Common Pleas, Hocking County Ohio.

The Petitioners Jonathan F. Card, William A. Gosline, Marcus V. Barbour and B.D. Babcock respectfully represent to this Court and say that they are citizens and residents of the State of Ohio, and have been such for many years last past, that they constitute in numbers more than two thirds of all the owners and proprietors of the real estate and property included within the map or Plat of Murray City, hereinafter mentioned. The Petitioners hereto attach a plat or map and mark the same, Exhibit "A" and make the same a part hereof and to which reference is here made and say that the same is a true copy or tracing of the plat of Murray City, Hocking County Ohio, and of which they are the present owners and proprietors; said petitioners say that said map or Plat was never in fact executed or acknowledged by the former owners and proprietors thereof and that the same was by mistake and oversight filed in the office of the Recorder of said County, by whom not known, that the same has been by said Recorder entered and Recorded in the Book of Plats in the office of said Recorder. Petitioners further say that the said map and plat is not now and never has been recognized by the officers of said County or said Petitioners as a legal and valid map and the Auditor of said County has declined and refused to have the same transferred as such upon the tax duplicate of said County, and said petitioners are now and have been paying for some years past the annual taxes upon said property under a description of said premises by metes and bounds, and not as lots, Petitioners say there is no occasion or necessity for said Real Estate being platted or remaining as such and that, it is for the interest of the owners, and proprietors thereof, that the same be vacated, wherefore said petitioners ask that an order be made in the Premises vacating and annulling the said Plat and Map of Murray City and for other and proper relief:
