We, the undersigned, SNORTIN RIDGE COMPANY, a General Partnership, duly organized and existing under the laws of the State of Ohio, owners of 79.316 acres in Perry Township, Hocking County, Ohio, do hereby certify and accept the attached plat as a true and correct representation of our subdivision, SNORTIN RIDGE, into lots, private roads and common space, of the premises herein described, being a part of Township No.13, and Range No.19.

Said 79.136 acres being part of Parcels F and J in Section Thirtysix (36) and part of Parcel G in Section Thirtyfive (35) as conveyed to the said SNORTIN RIDGE COMPANY by deed of record in Deed Book 148, Page 374, Recorder's Office, Hocking County, Ohio.

All roads shown within the platted area are private roads until such time as they meet all subdivision requirements and improvement standards in existence at the time of public acceptance. Roads comprise a total of 3.477 acres in Hocking County.

All roads shall be maintained and kept in good repair by SNORTIN RIDGE COMPANY and at no expense to any public agency.

No further subdivision of the numbered lots shown on this plat shall be permitted.

All of the private roadways shown on this plat, being 60 feet in width, may also be used as easements for the construction, operation, maintenance, repair, replacement or removal of utility lines, above and beneath the surface of the ground, and for the construction, operation and maintenance of service connections to adjacent lots.

The edge of the water, along lake front lots, is to be considered as the front property line. Building structure encroachment across edge of water shall be permitted. Side lot lines on lake front lots, are to continue on bearings shown, past the distances shown, on the plat, to said edge of the water.
