

# THE WASHINGTON BOWERS FIFTH ADDITION TO THE CITY OF LOGAN OHIO



Being a part of section 13T 14R 17, in the city of Logan, Hocking County Ohio and bounded as follows: Beginning at an iron pin at the NE corner of lot no 30 in Washington Bowers 4<sup>th</sup> addition to the city of Logan; thence S 67° 06'E 428.21 ft. to an iron pin; thence S 89° 09'E 127.61 ft. to an iron pin; thence S 25° 45'W 253.49 ft. to an iron pin; thence N 87° 09'W 130.0 ft. to an iron pin; thence S 25° 45'W 197.4 ft. to an iron pin; thence N 87° 09'W 205.45 ft. to an iron pin; thence N 58° 36'W 159.33 ft. to an iron pin; thence N 75° 09'W 112.84 ft. to an iron pin; thence N 75° 09'W 130.03 ft. to an iron pin; thence S 89° 20'E 34.7 ft. to an iron pin; thence N 10° 16'E 19.0 ft. to the place of beginning, containing 3.92 acre.


