

Proceedings before the Honorable Joseph G. Huffman one of the Judges in and for the First Sub-division of the Seventh Judicial District of Ohio, began and held at the Court House in the Town of Logan and County of Hocking on the 24th day of Nov. A.D. 1890,

Be it remembered that heretofore to wit; on the 22nd day of August A.D. 1890, came L. A. Culver and Ferdinand F. Rempel by Hansen and Smith their Attorneys and filed in the Office of the Clerk of the Court of Common Pleas their Petition, as follows:

Westenhaver's Addition to Logan.

Petition - The undersigned petitioners represent to the Court, that they are the exclusive owners, of what is known as the Samuel Westenhaver's Addition to the Village of Logan, Ohio, which addition was laid out, surveyed and platted by Samuel Westenhaver, April the 11th, 1882, and accepted by the town council of said Village of Logan February 20th 1883, and was duly left for record with the Recorder of Hocking County April 4th 1883.

Said addition is described as follows: Beginning at the North East corner of the North West quarter of Section No. 13, Township No. 14, Range No. 17, Hocking County Ohio; thence west 1003 links; thence south 1098 $\frac{1}{2}$ links, thence east 1003 links, thence north 1098 $\frac{1}{2}$ links to the beginning, containing 11.03 acres.

Said tract embraces 40 lots numbered from 686 to 725 inclusive with streets, avenues, alleys and roads necessary thereto; the dimensions of each of said lots, streets, avenues, alleys and roads, are written in links on the plat of said addition, as recorded in Record No. 1, Plats of Villages of Hocking County Ohio Page 99, in the recorder's office of said County.

Your petitioners further represents that none of the streets, avenues, alleys or roads of said addition have ever been opened or used by said Village or the public and that said addition is remote from and inaccessible to said Village. Your petitioners therefore ask that such proceedings may be had by the Court as are authorized by law and upon the final hearing of said petition that the court may make its order vacating said addition, and for all other relief.


