

Territory Detached from the Incorporated Village of Logan

To the Hon. Board of Commissioners, Hocking County, Ohio.

Now come Curana J Little, Mary L Dye, Louis Michel, John Ucker and John V Riff and represent that they are all of the freeholders in that portion of the attached territory to the Incorporated Village of Logan, Hocking County, Ohio, described as follows: Fractional Lot No. 12, in Section No. 11, Township No. 14, Range No. 17, Hocking County Ohio, now in the name of, and owned by, Curana J Little and Mary L Dye; Fractional Lot No 20, same Section, Township and Range, aforesaid, in the name of and owned by Louis Michel; A part of Fractional Lot No. 19 same Section Township and Range, beginning at a point $1-97/100$ chains North of the South East corner of said Fractional Lot No. 20 thence North 4.99 chains, thence West, 5.08 chains; thence South 4.99 chains; thence East 5.08 chains, to the place of beginning, containing $2-53/100$ acres in the name of, and owned by John Ucker and a part of Fractional Lot No 11, same Section Township and Range, beginning at a point where the west corporation line of said Village of Logan intersects the center line of the Hocking Canal, thence with the center of said canal in an easterly direction, 2.90 chains; thence North 16.46 chains, to the corporation line; thence West on said line, 3.36 chains, to the western line of said Village; thence South with west corporation line to the place of beginning, containing 4.97 acres in the name of, and owned by, John V Riff

They further say, that on the 24th day of May, 1898, the Council of the Incorporated Village of Logan, by ordinance duly passed, for that purpose, gave its assent that said described real estate be detached from the attached territory to said Village and attached to Falls Township, Hocking County, Ohio, a certified copy of said ordinance is hereto attached, marked Exhibit A and made a part of this petition.

They further say that an accurate map or plat of said real estate is hereto attached marked Exhibit B, and filed herewith.

Wherefore said petitioners pray: that said described territory be detached from the attached territory of said Village of Logan, Hocking County, Ohio, and attached to Falls Township in said County
